The proprietors of the Cemetery for Domestic Pets, their heirs and assigns (hereinafter called the Directors) appreciate that owners of pets buried in the Cemetery (hereinafter called the clients) are naturally anxious that their pets' remains shall not be disturbed after interment. The Directors wish, therefore to assure that it is their hope and intention, circumstances permitting, that the Cemetery should continue in existence indefinitely.

2. However, as it must regrettably be recognised that circumstances may change, the Directors wish to make it clear that they do not accept any legally binding responsibility to provide or to continue to provide a grave for any pet animal buried in the Cemetery.

3. Subject to the aforesaid conditions, and provided that annual cemetery maintenance fees (see below) are paid by the client at the rate currently in force, and that all charges payable by the client for services rendered and goods supplied have been met in full, the Directors undertake to provide a grave for a client's pet for so long as the Cemetery shall remain in existence.

4. Cemetery Maintenance Fees.

The annual fee in respect of Cemetery maintenance is due on the first of January annually and is payable at the appropriate rate, currently as follows :



Where the client is, without the consent of the Directors, in breach of this condition, the Directors shall have the right to provide from their own resources a headstone inscribed with the name of the pet, the entire cost thereof to be payable forthwith by the client concerned.

7. **Upkeep of Graves.** The Directors accept responsibility for the general appearance and maintenance of the Cemetery, including grass cutting and trimming the immediate vicinity of memorials. However, the maintenance and tidiness of grave areas enclosed by memorials, kerbs and surrounds, or delineated in any way, shall be the responsibility of the clients.

8. Loss or Damage. Headstones, memorials and other grave furnishings remain in the Cemetery entirely at owner's risk and the Directors accept no responsibility for loss or damage howsoever caused.

9. **Payments and Receipts.** Unless special arrangements have been entered into with the consent of the Directors, settlement of accounts for services rendered and goods supplied shall be within seven days of receipt of account by the client. Receipts will not be issued unless specially requested.


